Presidential Address of Dr Donna Breen, 2021–2022 President of the Southern Medical Association

The following is the presidential address of the Southern Medical Association's 2021–2022 president, Dr Donna Breen. Dr Breen was installed on Saturday, October 30, 2021, during the SMA Southern Regional Assembly, which was held October 28–30, 2021, in Lake Buena Vista, Florida, live and virtually.

Dr Morris, SMA Board Members, SMA and Alliance Members and Staff, I feel excited and honored to have been selected as your new president for 2022. First, let me introduce myself: I am an otolaryngologist, practicing general ear, nose, and throat medicine and allergy for the past 30 years in Marksville, Louisiana after finishing my residency at Tulane in 1988. I am a 1983 graduate of the University of Alabama Medical School. I am proud to serve the needs of my small-town community and care for both adults and children who would have to travel many miles for their care. I really get to know my patients and their families, as well as their extended families and friends, which engages me in their lives as their doctor, mentor, and friend. It is truly the best of both worlds, and I treasure my practice as a small-town physician.

My History with the SMA

I have been a member of SMA since 1984, when I was a resident at Tulane. At that time, I needed medical insurance and SMA offered quality insurance at great prices. Goals and Objectives

My first goal this year as your new president is to increase funding for our scholarships and research presentation awards, both the posters, as well as oral presentations, by increasing our monetary rewards for these entities as well as travel stipends. To increase participation in our seminars and Annual Assembly, let us provide adequate travel support to help residents and students attend our meeting, give better cash awards for best poster and research presentations, and increase our scholarship disbursements. I think we should be proactive in asking our financial partners as well as our membership to step up and be generous in rewarding good research. We can be a benefactor to the upand-coming doctors, and this would be our legacy. With more support, I would like to have prominent national speakers in many different fields that would promote attendance. I would suggest that we expand the days of our Annual Assembly for more presentations. This will allow for more physician-in-training participation as well.

My second objective is to ensure the legacy of our organization, which has survived for 115 years and give it another. With enthusiastic member involvement and participation in our programs, we will endure. Participation in organized medicine is not the priority it once was in the past. There are many reasons for this. We are competing with many different ways medical information is shared and knowledge acquired. We are at a watershed moment in the history of our country and the SMA as a purveyor of organized medicine. Today, the rapid dissemination of vast amounts of information, whether valid or not, requires a gatekeeper to act as arbiter of what is science or fiction. Organized medicine is the natural modality to channel this information and provide structure and validity.

Through intensive research and development, we now have the HIV virus contained and relegated to chronic nonlethal disease.
